Executive Summary

Voter turnout

Washington State's electorate grew to over 5 million active voters for the first time in 2024 (5,018,842 votes), and 79.5% voted in the 2024 General Election (3,989,857 ballots cast). Voter turnout was 4.6% lower than the 2020 General Election, and the second-lowest in a presidential election year since 2004. Turnout was highest in Northwestern WA and the Olympic Peninsula; among rural voters and voters making >\$150,000 annually; among White voters; and among voters over the age of 65. Turnout was lowest in South Central WA and North Central WA; among voters living in urban areas and voters making <\$50,000 annually; among Native American and Latino voters; and among voters 25-34 years old. More than 50% of those who did not vote in the 2024 General Election voted at least once since 2021, and nearly 430,000 voters who voted in the 2020 General Election did not vote this year. The dropoff in voter turnout was most pronounced among parts of South King County and the Yakima Valley with a high density of young and Latino voters

Voter outreach

In the three months leading up to election day, WCA's network of community-based organizations and labor unions made 1,266,662 direct voter contact attempts – including 151,183 door knocks, 571,646 phone calls, and 543,833 text messages – and sent 1,734,317 mailers to voters throughout Washington, including voters in every county, congressional district, and legislative district in the state. Together with the Defend WA coalition, our network had 164,186 conversations with voters, and conversations led to statistically significant increases in voter turnout both in-person (+10.8%) and over the phone (+5.3%). Traditional in-person canvassing had the highest contact rate and the highest impact on voter turnout, particularly among groups of voters who tend to vote less frequently (younger voters and voters of color).

Election results

Compared to the rest of the nation, the 2024 General Election was a resounding victory for Washington State Democrats: Democrats swept all statewide offices for the first time since the 1960s, flipped two legislative seats (LD26 State Representative Pos. 1 and LD18 State Senator) to expand their majorities in both chambers of the state legislature, and defeated 3 statewide initiatives seeking to roll-back recent progressive legislation (I-2109, a repeal of the Capital Gains Tax; I-2117, a gutting of the Climate Commitment Act; and I-2124, an opt-out for the WA Cares payroll tax). In the presidential race, the margin moved slightly to the right compared to 2020 (D+18.4% vs D+19.2%), but both nominees received fewer votes than in 2020: Kamala Harris received more votes in areas where turnout increased and fewer votes in areas where turnout decreased; while Donald Trump received a comparable number of votes in all areas, regardless of changes in turnout. This suggests that precinct-level shifts towards Trump may have been due to voter apathy (Biden 2020 voters not voting in 2024) rather than voter realignment (Biden 2020 voters voting for Trump in 2024). Overall, the 2024 General Election results in Washington State were a strong endorsement of Democratic candidates and progressive taxation measures.

Electorate & Turnout

Washington's Electorate






Fig 1.1 | Demographic composition of Washington's electorate in November, 2024. Washington's electorate aggregated by (**I**) age, (**II**) race, and (**III**) sex & marital status. (**IV**) Density of voters per county, divided by age, race, or marital status. Washington's voter file was last updated on October 17th, 2024, so anyone who registered after that will not be included here. "Unknown" includes individuals who cannot be categorized into any of the other race buckets, typically those who identify as multiracial or who recently registered to vote.

Washington State's electorate grew to over 5 million active voters for the first time ever in 2024 (5,018,842 voters), with 167,028 new voters registering in 2024 alone. Compared to the overall electorate, Washington's newly registered voters are markedly younger (median age, 31 years old vs 48 years old) and more racially diverse (30.0% vs 17.8%). More than half of all new voters registered in the Puget Sound (+95,017 voters), though Southwestern WA (+19,976 voters), Eastern WA (+14,207 voters), South Central WA (+11,695 voters), and the Olympic Peninsula (+11,963 voters) all saw sizable new registrations. Relative to each region's overall electorate, Southwestern Washington saw the greatest growth in its electorate (+3.6%), followed by the Puget Sound (+3.2%), the Olympic Peninsula (+3.0%), and Northwestern Washington (+2.8%) (**Fig 1.1**).

White voters are the largest voting group in Washington State (4,388,326 voters), but the slowest growing group (+2.7% in 2024). 27% of White voters are under the age of 35 years old, while another 27% are over the age of 65 years old. The largest share of White voters live in the Puget Sound (52%), followed by Southwestern WA and Eastern WA (11% each), and the Olympic Peninsula, WA, and South Central WA (7-8% each). White voters make up the largest share of the electorates in Seattle (~428k voters), Vancouver (~216k voters), Spokane (~204k voters), Tacoma (~144k voters), Olympia (~103k voters), and Bellingham (~89k voters).

Asian American and Pacific Islander (AAPI) voters are the second largest voting group in Washington State (353,330 voters), as well as the second fastest growing group (+5.2% in 2024). One-third of AAPI voters are under the age of 35, while 17% are over the age of 64. The vast majority of AAPI voters live in the Puget Sound (87.5%; less than 5% in each other region), with the highest densities in Seattle (~68k voters), Bellevue (~24k voters), Renton (~18k voters), Kent (~16k voters), and Tacoma (~14k voters).

Despite making up the second-largest share of Washington's overall population, Latino voters are the third largest voting group in Washington State (321,747 voters). However, Latino voters are the fastest growing segment of Washington's electorate, with an increase of more than 16,000 voters this year alone. (+5.5% in 2024).

51% of all Latino voters are under the age of 35, while just 9.5% are over the age of 64. The majority of Latino voters live in the Puget Sound or South Central WA (44% and 26%, respectively, with ~5-7% in each other region), with the highest densities in Seattle (~22k voters), Yakima (~18k voters), Pasco (~16k voters), Vancouver (~13k voters), Tacoma (~13k voters), and Kennewick (~9k voters).

Black voters are the fourth largest voting group in Washington State (145,387 voters), and the third fastest growing (+4.6% in 2024). More than 40% of Black voters are under the age of 35, and just 11% are over the age of 64. Similar to AAPI voters, the vast majority of Black voters live in the Puget Sound (84.6%; less than 4% in each other region), with the highest densities in Seattle (~30k voters), Tacoma (~16k voters), Kent (~8k voters), Federal Way (~7k voters), and Renton (~6k voters).

Importantly, in addition to Washington's ~5 million active voters, there are 548,191 "inactive" voters throughout the state. Voters have their registration status changed to inactive if the postal service has been unable to deliver a ballot to the address listed on their voter registration, typically because that voter has moved and not updated their registration¹. If a voter remains inactive for two consecutive federal general elections (i.e., even-year elections), that voter is fully dropped from the voter file².





Among Washington's inactive voters, 57% voted in the 2020 General election and 61% voted at least once in 2021, 2022, or 2023. The largest shares of inactive voters are 25-34 year olds (32%) and 35-44 year olds (22%), and more than three-quarters of all inactive voters are White (78%). All other analyses in this report follow the Secretary of State's guidance in excluding inactive voters, since those voters are unable to receive their ballots via the mail. Re-engaging inactive voters should be a top priority for groups working towards full participation in Washington's electorate.

Voter turnout

Voter turnout in the 2024 General election was 79.5% (3,989,857 ballots cast), a 4.6% decrease from 2020 and the second-lowest turnout during a presidential election since 2004 (**Fig 1.2**). Turnout was highest in Northwestern WA (82.5%), the Olympic Peninsula (80.6%), and Southwestern WA (80.2%), and lowest in South Central WA (73.8%) and North Central WA (77.1%). South Central WA and the Puget Sound were the only regions where turnout more than doubled from the Primary to the General (+103% and +102%, respectively), with a greater share of infrequent, irregular voters in each region (voting ≤1x per year).

Overall, turnout was higher among voters living in rural areas (80.9%) than voters living in suburban (78.8%) or urban (77.1%) areas, and turnout was positively correlated with income, with highest turnout among voters earning greater than \$150,000 annually (90.7%) and lowest among voters earning less than \$50,000 annually (58.8%). Turnout was highest among White voters (82.2%), AAPI voters (67.3%), and Black voters (63.7%), and lowest among Native American voters (59.2%) and Latino voters (57.3%). Although turnout generally increased with age, turnout was lower among 22-26 year olds than 18-21 year olds, suggesting greater enthusiasm among those voting in their first ever presidential election. 70% of voters who registered to vote in 2024 cast a ballot, including 60% of new voters of color and 67% of new voters \leq 35 years old.

Among Washington's 5 million voters, 36% voted in this year's Primary and General elections, another 36% only voted in the General election, less than 1% only voted in the Primary election, and 28% did not vote in either election. Notably, more than 50% of those who did not

vote in this year's General election (~520k voters) voted at least once since 2021, suggesting particularly dampened voter enthusiasm specific to the 2024 presidential election for a segment of the electorate. Relative to 2020, voter turnout in Washington State decreased in every region and among every demographic group, with a "dropoff" (voted in 2020 but not 2024) of nearly 430k voters. The dropoff in voter turnout was highest in South Central WA (-6.5%), the Puget Sound (-6.1%), and North Central WA (-6%), and lowest in South Central WA (-4.2%) and the Olympic Peninsula (-4.5%). Voter dropoff from 2020 was highest in urban and suburban areas (-5.7% and -5.0%, respectively), and lowest in rural areas (-4.0%). Overall, voter dropoff was lowest for White voters (-4.3%) but 2-3x higher for all other voters (AAPI: -9.6%; Black: -12.4%; Latino: -10.9%; Native American: -10.7%). Unlike overall trends in voter turnout, the dropoff in turnout was not linear across age groups, with the lowest dropoff among 22-24 year olds (-3.5%) and the highest dropoff among 25-34 year olds (-5.6%) and 45-54 year olds (-4.8%). Similarly, voter dropoff from 2020 was not directly correlated with income: although dropoff was lowest for voters earning >\$150k per year (-2.6%), dropoff for the lowest earning voters was smaller than for mid-earners (<\$50k: -6.0%; \$50-75k: -6.4%; \$75-100k: -6.5%).

Although fewer ballots were cast in Washington in 2024 than in 2020 (3,812,035 vs 4,096,370), more ballots were rejected by county auditors and canvassing boards - both a larger number overall (37,551 vs 31,725 ballots) and a larger share of total votes (0.98% vs 0.77% of all votes). In 2024, most ballots were rejected because of a mismatched signature (signature on ballot not matching signatures on file; 26,429 ballots), because they were missing a signature altogether (7,127 ballots), or because they were received too late (after 8pm on November 5th, 2024). Compared to 2020, fewer ballots were returned with mismatched signatures (73.6% vs 76.9%) or too late to be counted (6.6% vs 8.0% of all rejections), but more ballots were returned unsigned (19.8% vs 15.1%). A greater share of all challenged ballots were returned by voters under 35 than voters 35 and older (57.8% vs 42.2% of all challenged ballots), and the majority of challenged ballots were returned by White voters (73.9% of all challenged ballots) and by voters in the Puget Sound (51.3% of all challenged ballots). 11% of voters whose ballots were rejected in 2020 also had their ballots rejected in 2024, and 99% of those were rejected for the same reason: a signature mismatch compared to the signature on file.

Voter Outreach

Summary




Fig 1.3 | Summary of voter outreach work done by WCA Data Hub partners in the 2024 General Election. Total voter contact attempts aggregated by **(I)** contact method and **(II)** county, and **(III)** daily contact attempts by contact method. **(IV-V)** Contact rate of **(IV)** phone calls or **(V)** door knocks on the relative impact on turnout, for all voters and by race & age. Gray lines under "All voters" show individual organizations' voter outreach work. Only includes data between the 2024 Primary and General Elections (8/6/24 to 11/6/24) that was uploaded to the VAN.

The WCA Data Hub supports a network of communitybased organizations and labor unions with their civic engagement work, including voter registration and education programs, legislative advocacy, and Get-Out-The-Vote (GOTV) activities. 26 of our partner organizations were involved in direct voter outreach work in the three months leading up to the 2024 General Election, and collectively made 1,266,662 direct voter contact attempts – including 151,183 door knocks, 571,646 phone calls, and 543,833 text messages – and sent 1,734,317 mailers or pieces of lit to voters throughout Washington. This included contact attempts and conversations with voters in every county, congressional district, and legislative district in the state (**Fig 1.3**).

Together with the Defend WA campaigns, our network had 164,186 conversations with voters, including 38,019 at their door, 114,157 over the phone, and 11,999 over text. Overall, conversations with voters led to statistically significant increases in voter turnout (in-person: +10.8%; phone: +5.3%), and the relative impact was significantly higher for outreach that happened within two weeks of Election Day (+12.2% vs +1.3%). All in all, the data highlights the power of traditional canvassing work on energizing voters, particularly when voters already have their ballots in hand.

In-person canvassing

17 Data Hub partners led in-person voter outreach programs in 2024, including traditional door-to-door canvassing, deep canvassing, and community events (such as ballot parties). The largest field programs were conducted in the Puget Sound (King, Pierce, and Snohomish), South Central WA (Yakima), Eastern WA (Spokane), North Central WA (Okanogan and Chelan), and Southwestern WA (Pacific and Clark). Overall, in-person canvassing had a 15.1% contact rate, and turnout of voters who were canvassed at the door was 10.8% higher than voters who were not canvassed. This effect was higher for Native American (+15%), Black (+12%), and AAPI voters (+7%) than for Latino and White voters (+3% each); higher for voters 35 and older than voters under 35 (+8% vs +4%); higher for men than women (+9.4% vs +6%); and higher for voters who did not vote in the 2020 General Election

than voters who did (+5.6% vs +2%). The relative impact of in-person outreach also varied considerably by region: the effect was highest in Southwestern WA (+11.1%), the Puget Sound (+10.3%), and Eastern WA (+7.7%), and lowest in North Central WA (+2.4%) and the Olympic Peninsula (+2.4%). Importantly, in-person outreach had a positive impact on turnout across all demographic groups and in every region of the state, highlighting the importance of traditional on-the-ground, in-person outreach when motivating people to vote.

Phonebanking

16 Data Hub partners used phone calls to reach voters in the state, including traditional phone banks and paid calls from vendors. The largest phone programs were done in the Puget Sound (King, Pierce, and Snohomish), South Central WA (Yakima, Benton, and Franklin), and Eastern WA (Spokane). Overall, phone canvassing had a 17.7% contact rate, and turnout of voters who were canvassed over the phone was 5.3% higher than voters who were not canvassed. This effect was higher for Native American (+4.3%), AAPI (+3.5%), and Black voters (+2.7%) than for Latino (+0.7%) and White voters (-4.7%); higher for voters 35 and older than voters under 35 (+7% vs +6%); higher for women than men (+4% vs +2.8%); and higher for voters who did not vote in the 2020 General Election than voters who did (+13.6% vs +2.6%). Surprisingly, the relative impact of phone calls on voter turnout varied most heavily by region: the effect was highest in Northwestern WA, North Central WA, and South Central WA (+17.3%, +13.9%, and +9.2%, respectively), negligible in the Puget Sound (+0%), and lowest in Eastern WA (-10%). Since our partners typically focus their work in the communities they serve, this suggests that differences in targeting and messaging within individual organizations may have contributed to the overall success of phone calls in 2024.

Defend Washington

The WCA Data Hub also facilitated voter outreach for the Defend Washington coalition in the 2024 General Election. Collectively, the No on 2109, No on 2117, and No on 2124, campaigns made 3,662,651 direct voter contact attempts - including 138,384 door knocks, 769,547 phone calls, and 2,754,720 texts - and sent 9,347,998 pieces of mail to voters. This work targeted voters in every county, congressional district, and legislative district in the state, with the most targets in the Puget Sound (2 million), Southwestern WA (325k), and Eastern WA (289k), and the fewest targets in North Central WA (91k). In comparison to our Data Hub partners, whose work leading up to Election Day is heavily focused on GOTV of lower-propensity voters, the Defend WA campaigns focused primarily on persuading higher-propensity voters to vote "No" on the initiatives. For all three campaigns, there was a significant,




Fig 1.4 | Voter contact attempts by the Defend WA campaigns was correlated with "No" votes in the 2024 General Election. Linear regressions between total contact attempts (x-axis) and total "No" votes (y-axis) for the **(I)** No on 2109, **(II)** No on 2117, and **(III)** No on 2124 campaigns. All regressions were statistically significant, with *p* < 0.0001.


positive relationship between the total number of voter contact attempts and the total number of "No" votes per precinct, indicating that places where the campaign contacted the most voters also cast the most "No" votes against the initiatives (**Fig 1.4**). This effect was strongest for the No on 2117 campaign, which included more traditional field work than the other two campaigns, suggesting that in-person outreach and phonebanking were more effective at persuading voters than indirect outreach methods (mailers, texts, and digital ads).


15 of our partner organizations received funding from The Nature Conservancy to scale-up their field programs and talk to voters about I-2117, and the relative impact of our partner organizations surpassed that of the No on 2117 campaign. Our partners' work led to more conversations in-person (20,223 vs 14,851) and over the phone (28,142 vs 4,461) than the campaign, and the relative impact on voter turnout was greater for both in-person canvassing (+11.6% vs +1.8%) and phonebanking (+20% vs +5.6%). Our partners' work also focused more heavily on younger voters (44.8% vs 25.8%) and voters of color (73.4% vs 23.1%) than the campaign. The tactics and targeting of the campaign were notably different from our partners' focusing on persuasion of high-propensity voters vs GOTV of low-propensity voters - emphasizing the importance of working with trusted community messengers when targeting voters and groups who are historically less engaged with the electoral process.

Election Results


Overview

Washington's 2024 General Election included 12 federal races, 16 statewide races and initiatives, 123 legislative races, and >200 local races and initiatives. 55% of all races were uncontested in Washington, with Washington ranking 13th in the nation for fewest uncontested races in 2024¹. 98% of incumbents won re-election in 2024, with most increasing their vote share since their last election. In an election year when Republicans gained ground in every state and across every demographic group, Washington State largely bucked the trend: although the margin in the presidential race moved 0.3% to the right (the smallest in the nation), Democratic candidates swept every statewide race for the first time since the 1960s. flipped two seats in the state legislature to expand their legislative majority, and unseated Republicans in countylevel races. Moreover, Washington voters overwhelmingly rejected efforts to repeal landmark pieces of progressive legislation, with a bipartisan coalition voting in support of progressive taxation.





Fig 1.6 | Change in Washington state's Presidential vote since 2016 and 2020. The shift in the Presidential margin from (I) 2016 to 2024 and (II) 2020 to 2024, aggregated by county, congressional district, and legislative district.


Federal races


Kamala Harris & Tim Walz finished first in the presidential race with 57.7% of the vote, winning Washington State and its 12 electoral votes (**Fig 1.5**). Harris & Walz were followed by Republican nominees Donald Trump & JD Walz with 39.3%, Independent candidates Robert F. Kennedy Jr. & Nichole Shanahan with 1.4%, Green nominees Jill Stein & Rudolph Ware with 0.8%, Libertarian nominees Chase Oliver & Mike ter Maat with 0.4%, Peace & Freedom nominees Claudia de la Cruz & Karina Garcia with 0.2%, and Independent candidates Cornel West & Melina Abdullah with 0.2% of the vote. All other candidates received ≤5,000 votes, and independent candidates overall received fewer votes than in 2020 or 2016 (3% in 2024, 3.2% in 2020, 7.6% in 2016).

Aside from Biden's 2020 vote share (58.0%), Harris' 2024 vote share (57.7%) was the highest for a Democratic nominee for President since Lyndon B. Johnson in 1964 (62.0%), which was also the last time Democratic candidates swept all statewide offices in Washington State. Conversely, although Trump's 2024 vote share was slightly higher than his 2016 and 2020 vote shares, he

received a smaller share of the overall vote than most Republican nominees over the same time span. Since 2016, most counties in North Central WA, Northwestern WA, the Olympic Peninsula, the Puget Sound, and Southwestern WA have moved to the left, though most counties in Eastern WA, North Central WA, South Central WA have moved to the right since 2020. The most pronounced shifts occurred in heavily-Latino counties in South Central WA. (**Fig 1.6**)

Although the margin in 2024 was slightly closer than in 2020 (D+18.4% vs D+19.2%; +715,045 votes vs +784,961), both nominees received fewer votes than in 2020: Trump received 58,144 fewer votes while Harris received 128,060 fewer votes than Joe Biden. Throughout Washington State, there was a significant negative relationship between drop in turnout from 2020 to 2024 and the drop in votes for Harris, but not any raw vote gains (or losses) to Trump: votes for Harris in 2024 were higher in areas where turnout increased from 2020, but lower in areas where turnout decreased; and votes for Trump in 2024 were unrelated to the change in turnout, regardless of direction. This effect was more tightly correlated with dropoff of young voters and voters of color than with the overall electorate, suggesting that decreased turnout among those groups of voters contributed to Harris' underperformance in 2024. Many areas of the state that saw the greatest shift towards Trump in 2024 - including the Yakima Valley and South King County – also saw the greatest drop in turnout of young voters and voters of color, suggesting that his improvement in those areas was partially from voter apathy, rather than simply voter realignment (Fig 1.7).




Fig 1.8 | Election results in Washington State's U.S. Senate race for the 2024 General Election. Bars are color-coded by candidates' declared party preference, asterisk indicates incumbent.

Senator Maria Cantwell (D) defeated Dr. Raul Garcia (R) 59.1% to 40.6%, winning re-election to a 5th term in the U.S. Senate. Cantwell received more votes than any other Democratic candidate in Washington in 2024, and won by a greater margin than her last re-election campaign (+18.5% vs +16.8%) (**Fig 1.8**).

Statewide races

Four statewide offices were open in 2024: Attorney General Bob Ferguson (D) defeated former U.S. Representative Dave Reichert (R) in the race for Governor, 55.5% to 44.3%; former U.S. Attorney Nick Brown (D) defeated Mayor Pete Serrano (R, Pasco) in the race for Attorney General, 55.6% to 44.3%; King County Councilor Dave Upthegrove (D) defeated former U.S. Representative Jaime Herrera




Fig 1.9 | Results in Washington State's partisan statewide races for the 2024 General Election. Bars are color-coded by candidates' party preference, asterisk indicates incumbents. Beutler (R) in the race for Commissioner of Public Lands, 52.6% to 47.1%; and State Senator Patty Kuderer (D, LD48) defeated State Senator Phil Fortunato (R, LD31) in the race for Insurance Commissioner, 56.6% to 43.2% (**Fig 1.9**).

Washington's other four statewide offices included incumbent Democrats running for re-election: incumbent Lt. Governor Denny Heck (D) defeated Dan Matthews (R) in the race for Lt. Governor, 55.7% to 44.2%, winning re-election to a 2nd term; incumbent Secretary of State Steve Hobbs (D) defeated Dale Whitaker (R) in the race for Secretary of State, 59.2% to 40.7%, winning re-election to his 1st full-term; incumbent State Auditor Pat McCarthy (D) defeated Matt Hawkins (R) in the race for State Auditor, 58.0% to 41.9%, winning re-election to a 3rd term; and incumbent State Treasurer Mike Pellicciotti (D) defeated Sharon Hanek (R) in the race for State Treasurer, 57.3% to 42.6%, winning re-election to a 2nd term. This was the first time since the 1960s that Democratic candidates swept all partisan statewide offices in Washington (**Fig 1.9**).

Four non-partisan statewide races were also on the ballot in the 2024 General Election: incumbent Chris Reykdal




Fig 1.10 | Results in Washington State's nonpartisan statewide races for the 2024 General Election. Asterisk indicates incumbents.




Fig 1.11 | Washington's statewide ballot initiatives in 2024. Four initiatives received enough signatures to qualify for the 2024 General Election: I-2066, banning the regulation of natural gas; I-2109, repealing the Capital Gains Tax; I-2117, eliminating the cap-and-trade provision of the Climate Commitment Act; and I-2124, allowing individuals to opt-out of the WA Cares payroll tax.

defeated School Board Director David Olson (Peninsula School District) in the race for Superintendent of Public Instruction, 52.8% to 46.6%, winning re-election to a 3rd term; Attorney Sal Mungia narrowly defeated Judge Dave Larson in the open contest for Supreme Court Justice Pos. 2, 50.0% to 49.4%; incumbent Supreme Court Justice Steve González ran unopposed in the race for Pos. 8, receiving 97.6% of the vote and winning re-election to a 3rd term; and incumbent Supreme Court Justice Sheryl Gordon McCloud ran unopposed in the race for Pos. 9, receiving 97.5% of the vote and winning re-election to a 3rd term (**Fig 1.10**). All non-partisan races were won by Democraticendorsed candidates, indicating broad support for Democrats in 2024.

Statewide initiatives

Washington's 2024 General Election featured four statewide ballot initiatives, all attempting to roll back recent progressive policies and sponsored by the group Let's Go Washington. Let's Go Washington, launched in 2022 by hedge fund billionaire Brian Heywood, was a multi-year strategy to repeal 11 progressive policies passed by the state legislature. In 2023, the group narrowed their focus to six priorities, and spent \$7.8 million - \$6.4 million from Heywood alone – gathering signatures. By January 2024, all six measures had gathered enough signatures to qualify for the November election, and were sent to the legislature. In late March, near the end of the 2024 Legislative Session, the Democratic-controlled legislature opted to pass three of the measures and referred the remaining three measures to voters in the 2024 General Election. In late July, a fourth ballot initiative also received enough signatures to qualify for the ballot (Fig 1.11).

In response, a coalition of community-based organizations, tribal nations, labor unions, and national advocacy groups formed Defend Washington to fight the initiatives. In a major win for Defend Washington, a Thurston County judge ruled in early June that the final wording of the ballot initiatives needed to include fiscal impact statements describing the impact of the repeal on existing programs: I-2109 would decrease funding for education; I-2117 would decrease funding for investments in clear air and water, renewable energy, and conservation projects; and I-2124 would decrease funding for WA's long-term care program. Notably, this ruling came before I-2066 qualified for the 2024 General Election, and no fiscal impact statement was required in its final wording.

Overall, Let's Go Washington raised \$9.4 million to support I-2066, I-2109, I-2117, and I-2124, focusing almost exclusively on digital ads. In contrast, Defend Washington and its associated committees raised \$41.3 million to oppose the initiatives, including \$302k opposing I-2066, \$4.4 million opposing I-2109, \$17.1 million opposing I-2117, \$13.8 million opposing I-2124, and \$5.7 million opposing the entire slate. In addition to digital ads, the Defend Washington coalition made more than 10 million direct voter contact attempts leading up to the General Election, including 8,994,042 mailers, 2,695,428 text messages, 694,201 phone calls, and 134,421 door knocks.

I-2066 was narrowly approved by voters, with 51.7% voting in support of the measure. I-2066 was the only initiative without a fiscal impact statement listed on the ballot, and more than 213k voters skipped over I-2066 on their ballots – nearly double the margin of victory for I-2066 (127k votes) and more than any of the other initiatives. Although I-2066 was rejected by voters in 5 counties in Western Washington (Clallam, Jefferson, King, San Juan, and Whatcom), there was a notable partisan divide in preference for I-2066 vs preference in the U.S. Presidential race: I-2066 underperformed Harris in Western and South Central WA, with a deficit of ≥20% throughout the Puget




Fig 1.12 | Statewide initiative results in Washington's 2024 General Election. (I) "Yes" and "No" votes for each initiative. I-2066 was approved by voters, and I-2109, I-2117, and I-2124 were rejected. **(II)** Margin between "Yes" and "No" votes for each county. **(III)** Difference between the "No" vote margin ("No" votes – "Yes" votes) and Kamala Harris' margin the presidential race (Harris votes – Trump votes), for each county.


Sound and Northwestern WA; but I-2066 overperformed Harris throughout rural Washington, particularly in Adams, Grant, and Pend Oreille counties (≥10%). 390k voters in King County alone voted for Harris for President while also voting "Yes" on I-2066 – more than triple the margin of victory for I-2066.

I-2109 was resoundingly rejected by voters, with 64.1% voting in opposition of the measure. I-2109 was rejected by voters in all 10 congressional districts, 47 of 49 legislative districts, and 32 of 39 counties. I-2109 received overwhelming bipartisan opposition throughout Washington, particularly in rural, working class areas of the state: "No" on 2109 underperformed Harris in King and San Juan counties (-6.8% and -3.8%, respectively), but overperformed Harris in every other county, with \geq 30% of those who voted for Trump for President also voting "No" on I-2109 in Stevens, Okanogan, Lewis, Cowlitz, Douglas, Wahkiakum, Ferry, Grant, Lincoln, Pend Oreille, Garfield, Columbia, Asotin, and Adams counties.

Similar to I-2109, I-2117 was resoundingly rejected by voters, with 62.0% voting in opposition of the measure. I-2117 was rejected by voters in 9 congressional districts, 39 legislative districts, and 24 counties. I-2117 also received broad bipartisan opposition, outperforming Harris in every county except King and San Juan (-2% and -0.8%, respectively). The defeat of I-2117 shows a marked shift from the last time Washingtonians voted on a climaterelated ballot initiative, when 2018's I-1631 – which would have established a carbon fee – was rejected by votes 56% to 44%.

I-2124 was more narrowly rejected by voters, with 55.5% voting in opposition of the measure. I-2124 was rejected by voters in 8 congressional districts, 34 legislative districts, and 24 counties. Similar to I-2109 and I-2117, the defeat of I-2124 was driven by bipartisan opposition: although I-2124 underperformed Harris throughout the Puget Sound and Northwestern Washington (including a 29% deficit in King County), I-2124 overperformed Harris in every county in Eastern, North Central, South Central, and Southwestern WA, with ≥25% of voters voting for Trump for President and "No" on 2124 in Stevens, Grant, Wahkiakum, Lincoln, Columbia, Asotin, Ferry, Garfield, Adams, and Pend Oreille counties (**Fig 1.12**).



Overview

Election results

Every incumbent U.S. Representative from Washington who ran for re-election in 2024 won their races: Rick Larsen (D, CD2), Marie Gluesenkamp Perez (D, CD3), Kim Schrier (D, CD8), and Marilyn Strickland (D, CD10) won their races by a larger margin than in 2022, while Suzan DelBene (D, CD1), Dan Newhouse (R, CD4), Pramila Jayapal (D, CD7), and Adam Smith (D, CD9) won their races by a narrower margin. Both of Washington's open congressional races were won by candidates of the same party as the retiring U.S. Representative: former State Senator Michael Baumgartner (R) won his race in CD5, and State Senator Emily Randall (D) won her race in CD6. Incumbents Newhouse (R) and Smith (D) faced intra-party

challenges from candidates to their ideological right and left, respectively, and their races were considerably closer in 2024 than in 2022, when they faced opponents from the other party (Newhouse: 5.9% vs 35%; Smith: 33% vs 43%). Five incumbent Democrats – DelBene (CD1), Larsen (CD2), Gluesenkamp Perez (CD3), Schrier (CD8), and Strickland (CD10) – received a larger share of the vote in their districts than Democratic presidential nominee Kamala Harris. Gluesenkamp Perez was the only Democrat to win in CD3 in 2024, outperforming all Democratic candidates for statewide and federal offices lost by ≥5% each.

Congressional delegation

Washington's congressional delegation for the 2025-2026 term will include 8 Democrats and 2 Republicans. This will be Randall and Baumgartner's first term in Congress, Gluesenkamp Perez's 2nd term, Strickland's 3rd term, Schrier's 4th term, Jayapal and Newhouse's 5th term, DelBene's 7th term, Larsen's 13th term, and Smith's 15th term. Randall will be the first openly-LGBTQ person ever elected to Congress from Washington, and the first openly-LGBTQ Latina elected to Congress from any state.

Young voters make up 26.7% of the electorate in CD1 (122,469 voters under 35), and turnout of young voters was 14.2% lower than older voters (70.0% vs 84.2%). Voters of color comprise 20.7% of the electorate in CD1, and turnout of voters of color was 13.8% lower than White voters (69.4% vs 83.2%). 


Fig 2.3 | Voter turnout in CD1 in the 2024 General Election. Pie charts (left) show the electorate composition, bar graphs (right) show voter turnout by age or race.





Fig 2.4 | Election results in CDI for the 2024 General Election.




Fig 2.5 | Voter turnout in CD2 in the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.




Fig 2.6 | Election results in CD2 for the 2024 General Election.

Bars are color-coded by candidates' declared party preference, asterisk indicates incumbent.






Fig 2.7 | Voter turnout in CD3 in the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.




Fig 2.8 | Election results in CD3 for the 2024 General Election.





Fig 2.10 | Election results in CD4 for the 2024 General Election.




Fig 2.9 | Voter turnout in CD4 in the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.






Fig 2.12 | Election results in CD5 for the 2024 General Election.




Fig 2.11 | Voter turnout in CD5 in the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.





Fig 2.14 | Election results in CD6 for the 2024 General Election. Bars are color-coded by candidates' declared party preference.




Fig 2.13 | Voter turnout in CD6 in the 2024 General Election. Pie charts (left) show the electorate composition, bar graphs (right) show voter turnout by age or race.





Fig 2.16 | Election results in CD7 for the 2024 General Election.




Fig 2.15 | Voter turnout in CD7 in the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.






Fig 2.17 | Voter turnout in CD8 in the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.




Fig 2.18 | Election results in CD8 for the 2024 General Election.






Fig 2.20 | Election results in CD9 for the 2024 General Election.




Fig 2.19 | Voter turnout in CD9 in the 2024 General Election. Pie charts (left) show the electorate composition, bar graphs (right) show voter turnout by age or race.






Fig 2.21 | Voter turnout in CD10 in the 2024 General Election.






Fig 2.22 | Election results in CD10 for the 2024 General Election.



Overview

Election results

In the 2024 General Election, all 98 State Representative positions were up for election, along with 25 State Senator positions. Every incumbent who ran for re-election won their race, and just two seats (LD26 State Representative Pos. 1 and LD18 State Senator) flipped party control. Only six districts had races with margins ≤5%, including LD5, LD10, LD14, LD17, LD18, and LD26. Across all 49 Legislative Districts in Washington, 28 Districts have all Democratic legislators, 18 have all Republican legislators, and just 3 have split delegations in the State Legislature, including LD10, LD18, and LD26. Despite marginal gains at the

Legislative control

Following the wins of State Senator-elect Adrian Cortes (D) in LD18 and State Representative-elect Adison Richards (D) in LD26, Washington Democrats have expanded their majorities in both legislative chambers by one seat each, with a 59-39 majority in the State House and a 30-19 majority in the State Senate. These are the largest Democratic majorities in the state legislature since 2008-2010, when Washington Democrats briefly had 64-35 and 31-18 majorities in the State House and State Senate, respectively.





Fig 3.2 | Legislative control for Washington's 2025 Legislative Session. Balance of seats in Washington's (**I**) State House of Representatives and (**II**) State Senate going into the 2025 Legislative Session. Washington Democrats will hold 59-39 and 30-19 majorities in the House and Senate, respectively.




Fig 3.3 | Voter turnout in LD1 for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs




Fig 3.4 | Election results in LD1 for the 2024 General Election.






Fig 3.5 | Voter turnout in LD2 for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs




Fig 3.6 | Election results in LD2 for the 2024 General Election.






Fig 3.7 | Voter turnout in LD3 for the 2024 General Election. Pie charts (left) show the electorate composition, bar graphs




Fig 3.8 | Election results in LD3 for the 2024 General Election.

Bars are color-coded by candidates' declared party preference, and asterisks indicate incumbents.






Fig 3.9 | Voter turnout in LD4 for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs




Fig 3.10 | Election results in LD4 for the 2024 General Election.






Fig 3.11 | Voter turnout in LD5 for the 2024 General Election.




Fig 3.12 | Election results in LD5 for the 2024 General Election.





Fig 3.13 | Voter turnout in LD6 for the 2024 General Election. Pie charts (left) show the electorate composition, bar graphs (right) show voter turnout by age or race.




Fig 3.14 | Election results in LD6 for the 2024 General Election.







Fig 3.15 | Voter turnout in LD7 for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.




Fig 3.16 | Election results in LD7 for the 2024 General Election. Bars are color-coded by candidates' declared party preference.







Fig 3.17 | Voter turnout in LD8 for the 2024 General Election.




Fig 3.18 | Election results in LD8 for the 2024 General Election.








Fig 3.19 | Voter turnout in LD9 for the 2024 General Election.





Fig 3.20 | Election results in LD9 for the 2024 General Election.




Fig 3.21 | Voter turnout in LD10 for the 2024 General Election.




Fig 3.22 | Election results in LD10 for the 2024 General Election.






Fig 3.23 | Voter turnout in LD11 for the 2024 General Election.




Fig 3.24 | Election results in LD11 for the 2024 General Election.







Fig 3.25 | Voter turnout in LD12 for the 2024 General Election.




Fig 3.26 | Election results in LD12 for the 2024 General Election.






Fig 3.27 | Voter turnout in LD13 for the 2024 General Election.





Fig 3.28 | Election results in LD13 for the 2024 General Election.





Fig 3.29 | Voter turnout in LD14 for the 2024 General Election.




Fig 3.30 | Election results in LD14 for the 2024 General Election.








Fig 3.31 | Voter turnout in LD15 for the 2024 General Election.




Fig 3.32 | Election results in LD15 for the 2024 General Election.






Fig 3.33 | Voter turnout in LD16 for the 2024 General Election.




Fig 3.34 | Election results in LD16 for the 2024 General Election.






Fig 3.35 | Voter turnout in LD17 for the 2024 General Election.




Fig 3.36 | Election results in LD17 for the 2024 General Election.







Fig 3.37 | Voter turnout in LD18 for the 2024 General Election.


Fig 3.38 | Election results in LD18 for the 2024 General Election.





Fig 3.39 | Voter turnout in LD19 for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs




Fig 3.40 | Election results in LD19 for the 2024 General Election.






Fig 3.41 | Voter turnout in LD20 for the 2024 General Election.





Fig 3.42 | Election results in LD20 for the 2024 General





Fig 3.43 | Voter turnout in LD21 for the 2024 General Election.




Fig 3.44 | Election results in LD21 for the 2024 General Election.







Fig 3.45 | Voter turnout in LD22 for the 2024 General Election.





Fig 3.46 | Election results in LD22 for the 2024 General Election.







Fig 3.47 | Voter turnout in LD23 for the 2024 General Election.





Fig 3.48 | Election results in LD23 for the 2024 General






Fig 3.49 | Voter turnout in LD24 for the 2024 General Election.






Fig 3.52 | Election results in LD25 for the 2024 General Election.




Fig 3.51 | Voter turnout in LD25 for the 2024 General Election.






Fig 3.53 | Voter turnout in LD26 for the 2024 General Election.





Fig 3.54 | Election results in LD26 for the 2024 General Election.




Fig 3.55 | Voter turnout in LD27 for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs





Fig 3.56 | Election results in LD27 for the 2024 General Election.






Fig 3.57 | Voter turnout in LD28 for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.




Fig 3.58 | Election results in LD28 for the 2024 General Election.







Fig 3.59 | Voter turnout in LD29 for the 2024 General Election.





Fig 3.60 | Election results in LD29 for the 2024 General





Fig 3.61 | Voter turnout in LD30 for the 2024 General Election.





Fig 3.62 | Election results in LD30 for the 2024 General Election.





Fig 3.63 | Voter turnout in LD31 for the 2024 General Election.




Fig 3.64 | Election results in LD31 for the 2024 General Election. Bars are color-coded by candidates' declared party preference,







Fig 3.65 | Voter turnout in LD32 for the 2024 General Election.





Fig 3.66 | Election results in LD32 for the 2024 General Election.




Fig 3.67 | Voter turnout in LD33 for the 2024 General Election.





Fig 3.68 | Election results in LD33 for the 2024 General Election.





Fig 3.69 | Voter turnout in LD34 for the 2024 General Election.





Fig 3.70 | Election results in LD34 for the 2024 General Election. Bars are color-coded by candidates' declared party preference, and asterisks indicate incumbents.






Fig 3.71 | Voter turnout in LD35 for the 2024 General Election.





Fig 3.72 | Election results in LD35 for the 2024 General Election.




Fig 3.73 | Voter turnout in LD36 for the 2024 General Election.




Fig 3.74 | Election results in LD36 for the 2024 General Election.






Fig 3.75 | Voter turnout in LD37 for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.





Fig 3.76 | Election results in LD37 for the 2024 General Election.





Fig 3.77 | Voter turnout in LD38 for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.





Fig 3.78 | Election results in LD38 for the 2024 General Election.






Fig 3.79 | Voter turnout in LD39 for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.




Fig 3.80 | Election results in LD39 for the 2024 General






Fig 3.82 | Election results in LD40 for the 2024 General




Fig 3.81 | Voter turnout in LD40 for the 2024 General Election.






Fig 3.83 | Voter turnout in LD41 for the 2024 General Election.




Fig 3.84 | Election results in LD41 for the 2024 General Election.







Fig 3.85 | Voter turnout in LD42 for the 2024 General Election.





Fig 3.86 | Election results in LD42 for the 2024 General





Fig 3.87 | Voter turnout in LD43 for the 2024 General Election.





Fig 3.88 | Election results in LD43 for the 2024 General




Fig 3.89 | Voter turnout in LD44 for the 2024 General Election.





Fig 3.90 | Election results in LD44 for the 2024 General Election. Bars are color-coded by candidates' declared party preference, and asterisks indicate incumbents.





Fig 3.91 | Voter turnout in LD45 for the 2024 General Election.




Fig 3.92 | Election results in LD45 for the 2024 General







Fig 3.93 | Voter turnout in LD46 for the 2024 General Election.




Fig 3.94 | Election results in LD46 for the 2024 General




Fig 3.95 | Voter turnout in LD47 for the 2024 General Election.




Fig 3.96 | Election results in LD47 for the 2024 General






Fig 3.97 | Voter turnout in LD48 for the 2024 General Election.




Fig 3.98 | Election results in LD48 for the 2024 General

Election. Bars are color-coded by candidates' declared party preference, and asterisks indicate incumbents.






Fig 3.99 | Voter turnout in LD49 for the 2024 General Election.




Fig 3.100 | Election results in LD49 for the 2024 General




Fig 4.1 | Electorate & voter turnout in Eastern WA for the 2024 General Election. Pie charts show the electorate composition and bar graphs show voter turnout, grouped by (**I**) age, (**II**) race, and (**III**) sex & marital status. (**IV**) Maps show precinct-level voter turnout, grouped by age, race, and marital status.

In the 2024 Presidential race, Trump won Eastern WA by 11.1%, and Trump's vote margin in Eastern WA in 2024 was 1.0% greater than in 2020. Asotin, Columbia, and Whitman counties all moved slightly to the left from 2020, while every other county moved to the right. Kamala Harris received a larger vote share in Spokane, Whitman, Asotin, and Columbia counties in 2024 than Hillary Clinton received in 2016, suggesting a gradual shift to the left in some areas of Eastern WA.

"No" on I-2109, I-2117, and I-2124 outperformed Kamala Harris in every county in Eastern WA, and voters in Eastern WA heavily split their tickets across the initiatives: every county voted "Yes" on I-2066 (banning natural gas regulation); 5 counties voted "Yes" and 5 counties voted "No" on I-2109 (repealing Capital Gains tax); 8 counties voted "Yes" and 2 counties (Spokane and Whitman) voted "No" on I-2117 (eliminate cap-and-trade provision of the Climate Commitment Act); and 7 counties voted "Yes" and 3 counties (Spokane, Whitman, and Asotin) voted "No" on I-2124 (opt-out of WA Cares).




Fig 4.2 | Results in Eastern WA for the 2024 Presidential Election and statewide initiatives. (I) Vote margin between Kamala Harris and Donald Trump in the Presidential Election. (II) Total number of statewide initiatives that received ≥50% "No" votes in the 2024 General Election.







Fig 4.3 | Voter turnout in Adams County for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.




Fig 4.4 | Election results in Adams County for the 2024 General Election. Bars are color-coded by candidates' declared party preference.








Fig 4.5 | Voter turnout in Asotin County for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.






Fig 4.6 | Election results in Asotin County for the 2024 General Election. Bars are color-coded by candidates' declared party preference.








Fig 4.7 | Voter turnout in Columbia County for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.




Fig 4.8 | Election results in Columbia County for the 2024 General Election. Both races were uncontested; bars are colorcoded by candidates' declared party preference.







Fig 4.9 | Voter turnout in Ferry County for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.




Fig 4.10 | Election results in Ferry County for the 2024 General Election. Bars are color-coded by candidates' declared party preference.






Fig 4.11 | Voter turnout in Garfield County for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.




Fig 4.12 | Election results in Garfield County for the 2024

General Election. Both races were uncontested; bars are colorcoded by candidates' declared party preference.








Fig 4.13 | Voter turnout in Lincoln County for the 2024 General Election. Pie charts (left) show the electorate composition, bar graphs (right) show voter turnout by age or race.




Fig 4.14 | Election results in Lincoln County for the 2024







Fig 4.15 | Voter turnout in Pend Oreille County for the


2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.




Fig 4.16 | Election results in Pend Oreille County for the 2024 General Election. Bars are color-coded by candidates' declared








Fig 4.17 | Voter turnout in Spokane County for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.




Fig 4.18 | Election results in Spokane County for the 2024

General Election. Bars are color-coded by candidates' declared party preference.







Fig 4.19 | Voter turnout in Stevens County for the 2024 General Election. Pie charts (left) show the electorate composition, bar graphs (right) show voter turnout by age or race.






Fig 4.20 | Election results in Stevens County for the 2024

General Election. Bars are color-coded by candidates' declared party preference.







Fig 4.21 | Voter turnout in Whitman County for the 2024




Fig 5.1 | Electorate & voter turnout in North Central WA for the 2024 General Election. Pie charts show the electorate composition and bar graphs show voter turnout, grouped by (I) age, (II) race, and (III) sex & marital status. (IV) Maps show precinct-level voter turnout, grouped by age, race, and marital status. than the 2016 General Election and 6.2% lower than the 2020 General Election, and 13,924 voters who voted in 2020 or 2022 did not vote in 2024, including 5,004 young voters and 4,105 voters of color.

In the 2024 Presidential race, Trump won North Central WA by 22.6%, and Trump's vote margin in North Central WA was 2.2% higher than in 2020, with the largest shifts in Douglas and Grant counties (+3.0% each). However, Kamala Harris received a larger vote share in Chelan, Douglas, and Okanogan counties in 2024 than Hillary Clinton received in 2016, indicating a gradual shift to the left in some parts of the region.

"No" on all four statewide initiatives – I-2066, I-2109, I-2117, and I-2124 – outperformed Kamala Harris in every county in North Central WA, and voters in North Central WA split their tickets across the initiatives: every county voted "Yes" on I-2066 (banning natural gas regulation); Grant voted "Yes" while Chelan, Douglas, and Okanogan voted "No" on I-2109 (repealing Capital Gains tax); Douglas and Grant voted "Yes" while Chelan and Okanogan voted "No" on I-2117 (eliminate cap-and-trade provision of the Climate Commitment Act); and Chelan, Douglas, and Grant voted "Yes" and Okanogan voted "No" on I-2124 (opt-out of WA Cares). Overall, these results could indicate a strong support for progressive taxation measures in a region that prefers Republican candidates for higher office.




Fig 5.2 | Results in North Central WA for the 2024 Presidential Election and statewide initiatives. (I) Vote margin between Kamala Harris and Donald Trump in the Presidential Election. (II) Total number of statewide initiatives that received ≥50% "No" votes in the 2024 General Election.






Fig 5.3 | Voter turnout in Chelan County for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.







Fig 5.5 | Voter turnout in Douglas County for the 2024 General Election. Pie charts (left) show the electorate composition, bar graphs (right) show voter turnout by age or race.




Fig 5.6 | Election results in Douglas County for the 2024

General Election. Bars are color-coded by candidates' declared party preference.








Fig 5.7 | Voter turnout in Grant County for the 2024 General Election. Pie charts (left) show the electorate composition, bar graphs (right) show voter turnout by age or race.




Fig 5.8 | Election results in Grant County for the 2024 General

Election. Bars are color-coded by candidates' declared party preference.







Fig 5.9 | Voter turnout in Okanogan County for the 2024 General Election. Pie charts (*left*) show the electorate





Fig 5.10 | Election results in Okanogan County for the 2024




Fig 6.1 | Electorate & voter turnout in Northwestern WA for the

Every county in Northwestern WA moved to the left from 2020, with the largest increase in Island County (+4.6%). Kamala Harris' vote share in 2024 was greater in every county than Biden's in 2020 or Clinton's in 2016, indicating a solid shift to the left throughout Northwestern WA.

"No" on I-2109 and I-2117 outperformed Kamala Harris in every county in Northwestern WA, while "No" on I-2066 and I-2124 underperformed Harris in every county. Voters in Northwestern WA were fairly unified against the initiatives: although Island and Skagit counties voted "Yes" on I-2066 (banning natural gas regulation), all four counties voted "No" on I-2109 (repealing Capital Gains tax), I-2117 (eliminate cap-and-trade provision of the Climate Commitment Act), and I-2124 (opt-out of WA Cares). Together, these results show strong support for both Democratic candidates and progressive taxation measures in Northwestern WA.




Fig 6.2 | Results in Northwestern WA for the 2024 Presidential Election and statewide initiatives. (I) Vote margin between Kamala Harris and Donald Trump in the Presidential Election. (II) Total number of statewide initiatives that received ≥50% "No" votes in the 2024 General Election.







Fig 6.3 | Voter turnout in Island County for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.




Fig 6.4 | Election results in Island County for the 2024 General







Fig 6.5 | Voter turnout in San Juan County for the 2024 General Election. Pie charts (left) show the electorate composition, bar graphs (right) show voter turnout by age or race.




Fig 6.6 | Election results in San Juan County for the 2024 General Election. Both races are nonpartisan offices.








Fig 6.7 | Voter turnout in Skagit County for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.




Fig 6.8 | Election results in Skagit County for the 2024 General Election. Bars are color-coded by candidates' declared party preference.







Fig 6.9 | Voter turnout in Whatcom County for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.





Fig 6.10 | Election results in Whatcom County for the 2024 General Election. All races were non-partisan.






Overview

Voter turnout

There are 371,129 registered voters in the Olympic Peninsula, and 299,843 voted in the 2024 General Election (80.8%). Young voters make up 20.4% of the electorate in the Olympic Peninsula (75,711 voters under 35), and turnout of young voters was 22.1% lower than older voters (63.2% vs 85.3%). Voters of color comprise 9.1% of the electorate in the Olympic Peninsula, and turnout of voters





of color was 16.5% lower than White voters (65.8% vs 82.3%). Turnout was 3.5% higher than the 2016 General Election and 3.8% lower than the 2020 General Election, and 30,155 voters who voted in 2020 or 2022 did not vote in 2024, including 9,641 young voters and 3,717 voters of color.

Election results

In the 2024 Presidential race, Kamala Harris won the Olympic Peninsula by 15.1%, and Harris' vote margin in the Olympic Peninsula was 2.8% greater than Biden's in 2020. Every county in the Olympic Peninsula moved to the left from 2020, with the largest increases in Clallam (+4.6) and Jefferson (+4.4%). Kamala Harris' vote share in 2024 was greater in every county than Biden's in 2020 or Clinton's in 2016, indicating a solid shift to the left throughout the Olympic Peninsula.

"No" on I-2109 and I-2117 outperformed Kamala Harris in every county in the Olympic Peninsula, while "No" on I-2066 and I-2124 varied throughout the region. Nevertheless, voters in the Olympic Peninsula were fairly unified against the initiatives: although Grays Harbor, Kitsap, and Mason voted "Yes" on I-2066 (banning natural gas regulation), every county voted "No" on I-2109 (repealing Capital Gains tax), I-2117 (eliminate cap-andtrade provision of the Climate Commitment Act), and I-2124 (opt-out of WA Cares). Together, these results show strong consistent and growing support for both Democratic candidates and progressive taxation measures in the Olympic Peninsula.




Fig 7.2 | Results in the Olympic Peninsula for the 2024 Presidential Election and statewide initiatives. (I) Vote margin between Kamala Harris and Donald Trump in the Presidential Election. (II) Total number of statewide initiatives that received ≥50% "No" votes in the 2024 General Election.





Fig 7.3 | Voter turnout in Clallam County for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.




Fig 7.4 | Election results in Clallam County for the 2024 General Election. Bars are color-coded by candidates' declared party preference.








Fig 7.5 | Voter turnout in Grays Harbor County for the 2024 General Election. Pie charts (left) show the electorate composition, bar graphs (right) show voter turnout by age or race.




Fig 7.6 | Election results in Grays Harbor County for the 2024 General Election. Bars are color-coded by candidates' declared





Fig 7.7 | Voter turnout in Jefferson County for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.




Fig 7.8 | Election results in Jefferson County for the 2024






Fig 7.9 | Voter turnout in Kitsap County for the 2024 General Election. Pie charts (left) show the electorate composition, bar graphs (right) show voter turnout by age or race.






Fig 7.10 | Election results in Kitsap County for the 2024 General






Fig 7.11 | Voter turnout in Mason County for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.





Fig 7.12 | Election results in Mason County for the 2024 General

Election. Bars are color-coded by candidates' declared party preference.






Fig 8.1 | Electorate & voter turnout in the Puget Sound for the




Fig 8.2 | Results in the Puget Sound for the 2024 Presidential Election and statewide initiatives. (I) Vote margin between Kamala Harris and Donald Trump in the Presidential Election. (II) Total number of statewide initiatives that received ≥50% "No" votes in the 2024 General Election.






Fig 8.3 | Voter turnout in King County for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.








Fig 8.7 | Election results in Pierce County for the 2024 General Election. Bars are color-coded by candidates' party preference.






Fig 8.9 | Election results in Snohomish County for the 2024 General Election. Non-partisan office.




Fig 8.8 | Voter turnout in Snohomish County for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.







Fig 8.10 | Voter turnout in Thurston County for the 2024

Overview

Electorate & turnout

There are 384,959 registered voters in South Central WA, and 284,895 voted in the 2024 General Election (74.0%). Young voters make up 28.3% of the electorate in South Central WA (108,758 voters under 35), and turnout of young voters was 23.3% lower than older voters (57.3% vs 80.6%). Voters of color comprise 24.1% of the electorate in South Central WA, and turnout of voters of color was 29.1% lower than White voters (51.9% vs 81.0%). Turnout was 0.7% lower than the 2016 General Election and 6.9% lower than




Fig 9.1 | Electorate & voter turnout in South Central WA for the

the 2020 General Election, and 37,307 voters who voted in 2020 or 2022 did not vote in 2024, including 14,215 young voters and 13,036 voters of color.

Election results

In the 2024 Presidential race, Donald Trump won South Central WA by 17.5%, and Trump's vote margin in South Central WA was 3.7% greater than in 2020. Relative to 2020, Klickitat and Walla Walla moved to the left (+0.1% and +0.8%), while every other county moved to the right. Harris' vote share in 2024 was greater than Clinton's 2016 vote share in Benton, Klickitat, and Walla Walla, while Trump's vote share in Yakima and Benton was his highest ever.

"No" on I-2109, I-2117, and I-2124 outperformed Harris in every county in South Central WA, while "No" on I-2066 underperformed Harris in every county. Voters in South Central WA were mixed on the initiatives: every county voted "Yes" on I-2066 (banning natural gas regulation) and "No" on I-2109 (repealing Capital Gains tax); and Kittitas, Benton, and Franklin voted "Yes" while Klickitat, Walla Walla, and Yakima voted "No" on I-2117 (eliminate capand-trade provision of the Climate Commitment Act) and I-2124 (opt-out of WA Cares).

LD14 (Yakima, Pasco) was redistricted earlier this year to increase the Latino proportion of the district to comply with the Voting Rights Act. Dampened turnout of Latino voters throughout the district helped Republicans hold its three legislative seats, though Democratic candidates narrowed the margins in each race to <10%.




Fig 9.2 | Results in South Central WA for the 2024 Presidential Election and statewide initiatives. (I) Vote margin between Kamala Harris and Donald Trump in the Presidential Election. (II) Total number of statewide initiatives that received ≥50% "No" votes in the 2024 General Election.






Fig 9.3 | Voter turnout in Benton County for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.




Fig 9.4 | Election results in Benton County for the 2024 General Election. Bars are color-coded by candidates' declared party preference.






Fig 9.5 | Voter turnout in Franklin County for the 2024 General Election. Pie charts (left) show the electorate composition, bar graphs (right) show voter turnout by age or race.




Fig 9.6 | Election results in Franklin County for the 2024






Fig 9.7 | Voter turnout in Kittitas County for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.




Fig 9.8 | Election results in Kittitas County for the 2024 General







Fig 9.9 | Voter turnout in Klickitat County for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.




Fig 9.10 | Election results in Klickitat County for the 2024

General Election. The top two candidates in each race will faceoff in the General Election. Bars are color-coded by candidates' declared party preference.







Fig 9.11 | Voter turnout in Walla Walla County for the

Fig 9.12 | Election results in Walla Walla County for the 2024 General Election. Bars are color-coded by candidates' declared party preference.







Fig 9.13 | Voter turnout in Yakima County for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.





Fig 9.14 | Election results in Yakima County for the 2024 General Election. Bars are color-coded by candidates' declared party preference.





Voters of color comprise 9.2% of the electorate in Southwestern WA, and turnout of voters of color was 17.7% lower than White voters (64.2% vs 81.9%). Turnout was 4.9%





higher than the 2016 General Election and 5.3% lower than the 2020 General Election, and 39,922 voters who voted in 2020 or 2022 did not vote in 2024, including 13,668 young voters and 4,786 voters of color.

Election results

In the 2024 Presidential race, Donald Trump won Southwestern WA by 2.3%, and Trump's vote margin in Southwestern WA was 1.0% greater than in 2020. Clark and Wahkiakum moved to the left from 2020 (+2% and +1.2%, respectively), while Skamania and Cowlitz moved to the right (+1.6% and +2.4%, respectively). Kamala Harris' vote share in 2024 was greater in every county except Cowlitz than Hillary Clinton's vote share in 2016. Notably, incumbent U.S. Representative Marie Gluesenkamp Perez (D) won her re-election in Southwestern WA's 3rd Congressional District, outperforming Kamala Harris by 4.9%.

"No" on the 2109, 2117, and 2124 initiatives outperformed Kamala Harris in every county across Southwestern WA, and voter sentiment on the initiatives was varied: every county voted "Yes" on I-2066 (banning natural gas regulation); every county except Lewis voted "No" on I-2109 (repealing Capital Gains tax); Cowlitz and Lewis voted "Yes" while Clark, Pacific, Skamania, and Wahkiakum voted "No" on I-2117 (eliminate cap-and-trade provision of the Climate Commitment Act) and I-2124 (opt-out of WA Cares). Together, these results show mixed support for Democratic candidates and progressive taxation.




Fig 10.2 | Results in Southwestern WA for the 2024 Presidential Election and statewide initiatives. (I) Vote margin between Kamala Harris and Donald Trump in the Presidential Election. (II) Total number of statewide initiatives that received ≥50% "No" votes in the 2024 General Election.








Fig 10.3 | Voter turnout in Clark County for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.




Fig 10.4 | Election results in Clark County for the 2024 General





Fig 10.5 | Voter turnout in Cowlitz County for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.




Fig 10.6 | Election results in Cowlitz County for the 2024






Fig 10.7 | Voter turnout in Lewis County for the 2024 General Election. Pie charts (left) show the electorate composition, bar graphs (right) show voter turnout by age or race.




Fig 10.8 | Election results in Lewis County for the 2024 General







Fig 10.9 | Voter turnout in Pacific County for the 2024 General Election. Pie charts (*left*) show the electorate composition, bar graphs (*right*) show voter turnout by age or race.




Fig 10.10 | Election results in Pacific County for the 2024

General Election. Bars are color-coded by candidates' declared party preference.







Fig 10.11 | Voter turnout in Skamania County for the 2024






Fig 10.12 | Election results in Skamania County for the 2024






Fig 10.13 | Voter turnout in Wahkiakum County for the




Fig 10.14 | Election results in Wahkiakum County for the 2024 General Election. Bars are color-coded by candidates' declared party preference.

Methodology

Electorate & turnout

Data on Washington's current population of registered voters ("electorate") was accessed via America Votes' Voter Activation Network (VAN). VAN data related to voter demographics, geography, and vote history was last updated on October 17th, 2024, so demographic data for anyone who registered to vote after that date will not be included in this report. All data processing and visualization was done using custom-written Python scripts, executed in a local Jupyter environment. Final ballot status reports ("matchbacks") for the 2024 General Election were downloaded from the Secretary of State's website, and voter ID's were mapped onto voter data from the VAN to update vote history data for these elections. To correct for any incomplete geographic information in the voter file, voters' precinct information was mapped onto corresponding district information (county council district, city, city council district, school district), and any missing values were updated.

Data on voters' age and sex were provided from the voter file, and data on voters' marital status and race was provided by Catalist, using mathematical modeling with census tract-level demographic data and a variety of other sources. Although extensively validated and highly accurate, modeled data is never 100% accurate, so there are minor inaccuracies in individual-level race data in the voter file; this should be considered when interpreting results and analyses of voter data accessed from the VAN. Race data is particularly inaccurate for Native American voters, who are far more likely to report multiracial identities in the U.S. Census. In general, these individuals are categorized as "Unknown", so the true count of Native Americans in Washington State likely includes some percentage of those folks. For some broader analyses of voting behavior and outreach impact, data on age and race was used to further categorize voters as "Young" (age = 18-34) or "Older" (age ≥ 35) and "BIPOC" (race = Black, AAPI, Hispanic, Native American, or Unknown) or "White" (race = White). "New voters" are those who registered to vote for the first time since 1/1/2024.

Voter outreach

Data on outreach work done by WCA Data Hub partners from August 7th, 2024 through November 7th, 2024 was accessed via America Votes' VAN (c4 outreach) and State Voices' VAN (c3 outreach). Voter IDs were used to map data related to outreach with the preprocessed voter file to allow detailed analyses. Only data collected by WCA Data Hub partners and returned to the VAN by November 20th, 2024 was included in this report, so the extent of voter engagement work may not be fully represented herein. For in-person canvassing and phonebanking outreach, the impact on voter turnout was assessed by comparing turnout of individuals who were successfully contacted ("canvassed") against turnout of individuals who were not contacted ("no contact").

Election results

Results for the 2020. 2022, and 2024 General Election were downloaded from the Washington Secretary of State's website, and processed and visualized using custom-written Python scripts. Data on the current incumbent for all races on the ballot this year was downloaded from the Secretary of State's website, and mapped onto the election results. Any incumbents running under different names than the previous time they ran (e.g., Jane M. Doe instead of Jane Doe) will be incorrectly marked as not being an incumbent. Party data for individual candidates was mapped from their self-reported "Preferred Party", and aggregated into four groups: Democratic, Republican, Independent/Other, or None (non-partisan races). Throughout this report, vote totals for candidates will be color-coded based on party affiliation. Although this report will focus on overall results, precinctlevel results can be found in the Washington General Election Dashboard, WCA's interactive tool for viewing and exploring election results.
